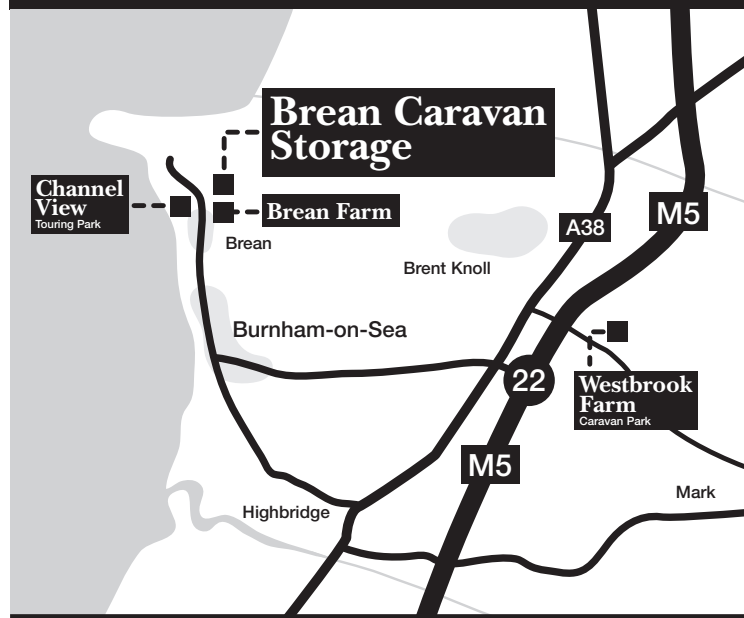

All payments for storage and tows to be made in advance.

All gas bottles to be disconnected and no other noxious, dangerous, hazardous or explosive goods are permitted.

Access to the holding bay is between the hours of 10am and 8pm for collections. Last drop off is 6pm (Sundays 5pm) access at any other time by arrangement, Minimum 24 hours notice for van removal during Summer months. In Winter months 7 days notice required and £20 charge made.

Notification must be given by 1st October if the caravan might be required between 1st November and 31st March. If no request has been received the caravan will not be accessible as it will be blocked in for the winter period.

Only Brean Caravan Storage authorised staff are allowed access to the storage compound.

Brean Caravan Storage and its staff are not held liable for any damage to any caravan or its contents as a result of towing or movement of the caravan unless to the proven negligence of Brean Caravan Storage or its authorised staff. Any suspected damage must be reported before leaving the holding bay or on immediate arrival at the caravan park.

All caravans must be insured and kept insured during the period of storage (a copy of the insurance document may be asked for) All caravans left at own risk.

All caravans must be kept in good condition with tyres, wheels, suspensions chassis, handbrake and jacklegs in good running order.

Caravans must not be inhabited during the storage period. No trading is permitted from the site, and the caravan must not be offered or advertised for sale while on site. No major repairs to be carried out on site (minor repairs may be carried out with the permission of the proprietor).

In the event of the storage fee being overdue the proprietor will retain possession of the caravan until arrears are settled in full or are otherwise discharged. The proprietor undertakes to notify the owner of the possession by recorded delivery. We operate a 3 month repossession policy on outstanding accounts and monthly £5 interest charge on outstanding accounts.

In the event of negative response to possession legal action will be taken to sell the caravan via **The Torts Interference with Goods Act 1977**. The outstanding balance (if any) will be retained to await collection. The proprietor will seek to obtain the best price available based on current market values.

The proprietor excludes all liability caused by Vermin Infestation, a recognised vermin control regime is in place and is monitored regularly.

No refund of fees will be made in the event of early departure.

In the performance of this contract of bailment the proprietor will at all times act with due diligence in providing secure storage.

The proprietor excludes all liability for loss or damage by whatever cause where means employed are in excess of due diligence.

Any change to the details provided by the plot holder in this agreement to be notified to the proprietor without undue delay.

The provision of a plot in the storage compound is deemed acceptance of these terms and conditions.

Periodic checks may be made on the identity of all the caravans stored on site.
